This affidavit must be completed for all inputs or ingredients purchased or traded, other than certified organic seed. It must be maintained with audit trail documentation and be available for the inspector to review at the time of inspection, along with seed tags and inoculant information, if applicable. If the affidavit is not on file at the time of inspection, this may delay the certification process, or, ultimately, result in denial of certification, as OCIA Standards clearly state genetically modified seeds and materials may not be used on OCIA certified farms. Please see the applicable Standards regarding prohibited substances/treatments and seed requirements.
